INTERIM ORDER

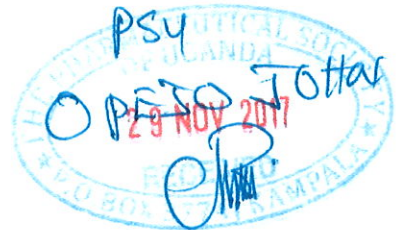
