Notice of the 2nd Pre-Internship/Eligibility Exam 2025

Subject to section 7(1) of the Pharmacy and Drugs Act CAP 309 Laws of Uganda, notice is hereby given of the 2nd pre-internship/eligibility examination 2025 to be conducted by the Council of the Pharmaceutical Society of Uganda on Thursday, 31st of July 2025 from 9 am to 12 noon. The venue for the said examination will be communicated in the invitation letters.

All eligible candidates are required to apply by 17:00hrs on Friday, 11th of July 2025. Applications should be done online and in hard copy with necessary attachments (See attached). The online application should be done via www.psucop.com, and also the hardcopy of the application should be physically submitted to the PSU Secretariat at Pharmacy House, Plot 1847 on East African Road, Banda-Kyambogo, Kampala.

Briefing and collecting invitation letters in person shall be held on Tuesday, 22nd July 2025 at Pharmacy House starting at 11:00 am.

Only candidates who meet all the requirements (See Continuation sheet) will be invited to sit for this examination.

REQUIREMENTS TO SIT PRE-INTERNSHIP EXAMS

Fresh applicants

- Hand-written application letter addressed to the Secretary Pharmaceutical Society of Uganda. The letter should be submitted by the applicant in person and explain why you think you should be considered for examination, and any special needs in case of such need that require attention of the council in considering your application.
- Pre-internship/Eligibility online application done through the PSU website www.psucop.com
- Curriculum vitae (C.V)
- University Admission Letter
- Certified academic transcript or its equivalent. Ugandan nationals trained in foreign countries or any applicant trained in a Ugandan university who has not yet graduated but completed the accredited Bachelor of Pharmacy program or its equivalent should attach a certified copy of their Testimonial of the results. There should be no pending retake in any course unit/module.
- Certified degree certificate or its equivalent. Regarding the degree certificate, the following will apply:
 - 1. For those applicants trained in Uganda, a letter of completion independently submitted to the Secretary of PSU by the Dean /Deputy or Head of Pharmacy, who should be a fully subscribed PSU member. The applicant should not have any retakes, but is only awaiting graduation. Such an applicant awaiting graduation should attach a graduation clearance form certified by the Dean /Deputy or Head of Pharmacy, who should be a fully subscribed PSU member.
 - 2. Ugandan nationals trained in foreign countries who have not yet graduated but completed the accredited Bachelor of Pharmacy program or its equivalent should attach a letter of completion from the university. This will be conditional.
 - 3. For those who trained in foreign countries and have graduated, an equivalent of your degree from the National Council for Higher Education.
- Work/resident permit (for non-Ugandans)
- Copy of A-level Certificate or its equivalent
- Copy of O-level Certificate or its equivalent
- Copy of Birth Certificate
- Copy of National ID
- Two clear-colored recent passport photos.
- Proof of payment of application fees (For Ugandans 260,000/=, two hundred sixty thousand shillings only) and for non-Ugandans 200 Dollars, Banked on 9030005895331 Stanbic Bank. Use Stanbic Bank branches and Stanbic Bank agents only. Please note: Avoid Mobile Money payments at this stage.

Applicants resitting the exam should submit:

- Written application letter addressed to the Secretary, Pharmaceutical Society of Uganda
- Pre-internship/Eligibility online application done through the PSU website www.psucop.com
- Copy of previous pre-internship results.
- Proof of payment of application fees (For Ugandans 260,000/=, two hundred sixty thousand shillings only) and non-Ugandans 200 Dollars, Banked on 9030005895331 Stanbic Bank. Use Stanbic Bank branches and Stanbic Bank agents only. Please note: Avoid Mobile Money payments at this stage.
